MOTOR VEHICLE LIABILITY AND COLLISION INSURANCE PREMIUM REDUCTION FOR COMPLETION OF AN ACCIDENT PREVENTION COURSE PURSUANT TO SECTIONS 2336(a)&(d) OF THE INSURANCE LAW

This Circular Letter updates and supersedes the earlier captioned Circular.
