RE: Circular Letters Nos. 1 (1980) With Supplements Nos. 1 & 2, Circular Letter No. 1 (1990) And Circular Letter Nos. 7 (1992) With Supplement
Motor Vehicle Liability And Collision Insurance Premium Reduction For Completion Of An Accident Prevention Course Pursuant To Sections 2336(a) & (d) Of The Insurance Law

This Circular Letter updates and supersedes the earlier captioned Circular Letters, in order to advise motor vehicle insurers of all Motor Vehicle Accident Prevention Course sponsors now approved by the Department of Motor Vehicles (DMV). The current and complete list of course sponsors is shown below. The latest changes, including additional sponsors, name, address and phone changes, are noted by an asterisk (*).
