2. The German employee who checked the packing of the objects restituted to France and shipped to Baden-Baden on 24 and 25 May 46, states that this drawing was on the rack with the French objects, and that she accordingly had it packed with them, though it was not named on the list of objects to be shipped.
3. It is thus possible that the drawing may have been sent to Baden-Baden, though it does not appear on the receipts or the packing lists. The boxes in one of which it is most likely to be are Nos. 3 and 4 (Collection Philipp Frank), 8 (Collection Frankfurt-Städtische Galerie, No.2), 14 (Collection Frankfurt-Städels Kunstinstitut, No.1) or 23 (Collection Heilbronn No.5).
4. It is requested that, when the boxes of the Wiesbaden shipment arrive in Paris and are unpacked, a search be made for this drawing and Lt. Lovegrove informed if it is found. If Lt. Lovegrove is no longer in Paris, it is requested that Capt. Standen be contacted at Wiesbaden (Telephone Wiesbaden 8892; address, Capt. E.A. Standen, Office of Military Government for Greater Hesse, MFA & A Section, APO 633, U.S.Army)

DESCRIPTION OF PROPERTY

In the years 1942 - 1944, after my business in Hamburg had been destroyed by bombs, I was buying as private dealer through the clearing paintings etc. in France for German Museums and institutions. My work and my person are well known to the American authorities for instance, to the Central Collecting Point in Munich. Gentlemen of this staff have visited and consulted me several times in regard to this matter and have, as a preliminary matter, seized my art objects for the Collecting Point Wiesbaden.

As all my business books and correspondences were destroyed in Dresden on the 13th of February 1945 the setting up of an exact list will be immensely difficult. One of the Art Officers of the Collecting Point Munich, whom I met last week in Munich, told me of his intention to visit me at Aschbach in a few days concerning this matter after his return from a trip to the former occupied areas in order to supply me with records.

I suppose that under these circumstances you will waive the submission of a declaration by myself.

I should like to add that I never belonged to the NSDAP, etc.

I testify that Dr. Hildebrand Gurlitt, whom I know for 25 years, in conformity with his entire mentality, took a stand which had to bring him into conflict with Nazism. The fights he got into with the Nazis before their accession to power, were doubtless the most disagreeable and vulgar experiences during this period of cultural struggle. Dr. Gurlitt has not only built up an excellent and in every manner representative museum which promoted the then modern art but had created a circle of friends and collectors of Art, a performance which might well be the envy of every expert, in provincial circles. The more vicious were then the vulgar attacks he had to suffer, even though a man like privy counsellor Justi, director of the "National Galerie in Berlin" took his part and defended him. His activity as director of the Hamburg Art Association also was in every way exemplary and full of a ravishing vitality. As an Artdealer, to which profession he was forced by the circumstances, he again took the side of the condemned "Degenerate Art" and saved many a masterpiece of this kind by bringing it into private ownership.

I know Dr. Hildebrand Gurlitt, now at Aschbach (Kr.Bamberg), since the year 1933 very well. Therefore I can testify, without reservation that he always has been an unlimited adversary of Nazism. The art-cabinet founded by him at Hamburg has been an island of refuge for the free art and expression. There gathered liberal minded people without regard to race and religion to exchange opinions freely and openly. They could do that as they were secure from denunciation and informers. In the house of Gurlitt especially the Art of every kind, also so called "Degenerate Art" found a home. There were shown to the friends of the house master-pieces of the different periods of Art, which had been condemned by the Nazi Government. The house of Gurlitt was a Center of culture where, undisturbed by the politicals and spiritual terror of Nazism, the idea of spiritual liberty was cherished and honored with care. That Mr. Gurlitt made his house a center of anti-Nazi activity must be recognized for him the twice punished (at Zwickau and Hamburg) jewish halfcaste. The intellectual circles of Hamburg, were deeply and sincerely sorry that Mr.Gurlitt, after the destruction of his Art Cabinet by air-raids in 1941 and 1942, left Famburg, in order to engage in the Art trade at some other place.

I voluntarily transmitted this declaration to Mr. Gurlitt in order to spare him the necessity to have to protest his antagonism against Nazism.

I myself, did not belong to either the NSDAP or one of its affiliated organizations. I am, with the sanction of the British Military Government, since July 1945 again engaged in the praxis of the law, and since August 1945 as commissary referee of Highschools with the administration of Education here.

As a half caste jewess and as a political persecuted person I should like to declare as follows:

From the first of January 1942 to the first of February 1944 I was employed as private secretary by Mister Gurlitt, Dresden A, 24 Kaitzerstreet 26. The entire correspondence of these two years went through my hands and I had also access to the correspondence files of the past years. I can testify, with the best of conscience that Dr. Gurlitt in his letters never expressed himself in any way in a pro-Nazi manner, and that I never signed his letters with "Heil Hitler". Also I had plenty of opportunity during these two years to learn of Dr. Gurlitt's antagonism to Nazism. I listened repeatedly to the allied Broadcasts and engaged in pro allied conversations. Dr. Gurlitt in spite of his very exposed situation, assisted in a self-sacrificing way the Jews and other political persecuted persons.

On the first of February I had to give up my position with Dr. Gurlitt as I was not permitted to do that kind of work any longer on account of my race. Although Dr. Gurlitt tried very hard to save me from being put to factory work, he did not succeed. For his great sympathy with my fate, I shall always feel obliged to Dr. Gurlitt.



On December 12 and 13 Dr. Gurlitt, Düsseldorf, and as witnesses Dr. Krause and Herr Pahl-Rugenstein, visited the Central Collecting Point. The collection of paintings has been shown to them, further a complete list of every item belonging to the Gurlitt collection was handed over to him. It was stated that he provides us for each item proof of ownership, with the exception of the paintings and sketches made by his grandfather Louis Gurlitt.

The general impression I got from Mr. Gurlitt is, that he does not seem very open-hearted. When showing him both Degas in the office I also tried to learn ~~at~~ something about the Renoir "Child's Head". He said: "Oh yes, yes, that is mine". Afterwards Dr. Krause made a remark like: "I cannot remember that". When we returned into the office Gurlitt went again to look at the Renoir, turned the painting round and seeing the label of Ette said: "No, it does not belong to me." I made my excuses for having him offered this painting. ~~offer~~ error

When we started inspecting the gallery I first picked out a picture of the Stettin Gallery. He made no definite statement about it, but said: "Oh, yes, that is all right" (He didn't state that it was his own picture, but also didn't refuse it definitely).

Showing him the Picasso he made some remarks of no importance giving the impression that he did not expect this picture either. But he recognized it as his property. Afterwards, when the inspection was over, he twice went back for a short moment to the Picasso picture and looked at it. Then I made a remark that it was dated and back in the office he suddenly said: "I could tell you a long and funny story about this picture. I tried to seem unconcerned. First giving us the impression that he did not know any thing of importance about this picture but after an hour being able to tell me a long and apparently complicated story about this picture.

The list was submitted to him in order to have his statements and the statements of the witnesses for the various items. I laid stress upon the following items:

Investigations were made by the German Kriminalpolizei, Wiesbaden and the USCID in order to recover the paintings, but without any success.

It is furthermore certified that the drawing by Rodin "Atlas" WIE 1977/59 was, erroneously, added to the large restitution shipment to France on May 24 and 25, 1946. The French authorities had been informed of this mistake by the then Director of the Wiesbaden Central Collecting Point, Capt. Edith M. Standen, and a request for restitution has been submitted to them. The Wiesbaden Central Collecting Point was, thereafter, notified by the French Authorities by letter of May 23, 1949, that the drawing had not been found among the above mentioned shipment. The drawing must, therefore, be considered lost.

Wir haben das fehlende Material nicht in unseren Listen verzeichnet und als letzte Hoffnung wende ich mich an Sie mit der Bitte nachzusehen, ob nicht versehentlich diese Sachen mit den 55 Kisten Ihrem Institut gehöriges Material enthaltend an Sie ausgeliefert worden sind.



Ihre Anfrage bezüglich der Rodin, Marmorplastik vom 21. Jan. haben wir erhalten.

Eine genaue Kontrolle unserer Akten ergab, daß niemals eine derartige Plastik durch den Collecting Point Wiesbaden empfangen wurde.

Ihre Sachen wurden zusammen mit den in Schloss Aschbach ausgelagerten Kunstgegenständen anderer Eigentümer nach Bamberg in die Neue Residenz überführt und von dort aus nach Wiesbaden gebracht.

Bis zur Übernahme durch die Amerikanischen Dienststellen stand das Depot Schloss Aschbach unter Aufsicht eines Herrn Zingraf. In Bamberg war der damalige Hausmeister der Neuen Residenz verantwortlich. Die anderen Eigentümer von in Schloss Aschbach ausgelagerten Gegenständen, welche ebenfalls durch die Amerikanischen Instanzen abtransportiert wurden, haben nicht feststellen können, daß von ihrem Eigentum etwas verschwunden ist. Wir nehmen daher an, daß vielleicht Ihre Rodin Plastik sich garnicht dort befunden hat, bzw. schon vorher verschwunden ist.

Da die damalige Hilfsdienststelle bereits seit geraumer Zeit geschlossen ist und wir uns auch im Abschlußstadium unserer Arbeiten befinden, sind wir leider nicht mehr in der Lage die Namen der Transportbegleiter von damals festzustellen, da die Akten bereits verpackt und abtransportiert worden sind.
