CONSENT ORDER

WHEREAS, the Department of Financial Services (the "Department") conducted an investigation of National Union Fire Insurance Company of Pittsburgh, PA (hereinafter "Respondent") regarding its issuance of blanket accident and health insurance policies to New York volunteer firefighter districts, departments and companies (hereinafter "volunteer firefighter companies").

WHEREAS, Respondent's blanket accident and health policies issued to certain New York volunteer firefighter companies from 2015 to 2017 violated 11 NYCRR 52.45(f) (Insurance Regulation 62) by failing to satisfy minimum loss ratio standards.

WHEREAS, Respondent violated Insurance Law § 3201(b) from 2015 to 2018 by charging unapproved premium rates on its blanket accident and health policies issued to certain New York volunteer firefighter companies.

WHEREAS, Respondent's failure to take adequate remedial action to address the inadequate performance of its blanket accident and health insurance policies issued to New York volunteer firefighter companies resulted in certain New York volunteer firefighter companies paying insurance premiums for coverage that did not bear a reasonable relationship to the benefits provided under the policies.

WHEREAS, the Department and Respondent are willing to resolve the matters cited herein in lieu of proceeding by notice and hearing.

NOW, THEREFORE, this Consent Order contains the Department's findings and the relief agreed to by the Department and Respondent.

BACKGROUND

- 1. Respondent is domiciled in Pennsylvania and is licensed as a property and casualty insurance company in New York. Pursuant to Insurance Law § 1113(a)(3), Respondent is authorized to write accident and health insurance in New York. Respondent offers blanket accident and health policies to groups in New York.
- 2. The Department commenced an investigation of Respondent requesting information regarding its issuance of blanket accident and health insurance policies to volunteer fire fighter companies in New York.
- 3. Respondent's blanket accident and health insurance policies issued to certain New York volunteer firefighter companies (see Appendix A) failed to comply with minimum loss ratio standards in 11 NYCRR 52.45(f) (Insurance Regulation 62). Pursuant to 11 NYCRR 52.45(f) (Insurance Regulation 62), the minimum loss ratio for blanket accident and health insurance policies shall be 65 percent, except that for insurance covering less than 50 persons at inception, excluding dependents, the minimum loss ratio shall be 60 percent. Respondent consistently maintained minimum loss ratios in the high 20 percent to low 30

percent range for a portion of the volunteer firefighter companies with less than 50 persons at inception.

4. From 2015 to 2018, Respondent did not use premiums rates that were filed with the Superintendent on its blanket accident and health policies issued to New York volunteer firefighter companies (See Appendix B). As a result, Respondent overcharged the New York volunteer firefighter companies.

FINDINGS

- 5. From 2015-2017, Respondent violated the minimum standards for the form, content and sale of health insurance in 11 NYCRR 52.45(f) (Insurance Regulation 62) by failing to adequately maintain minimum loss ratio standards applicable to blanket accident and health insurance.
- 6. From 2015-2017, Respondent failed to take adequate corrective or remedial measures to address the substandard performance of the Respondent's blanket accident and health insurance issued to New York volunteer firefighter companies resulting in certain New York volunteer firefighter companies paying insurance premiums for policies that did not bear a reasonable relationship to the benefits provided under the policies. Respondent's failure to maintain minimum loss ratios in compliance with law resulted in certain New York volunteer firefighter companies being overcharged for premiums in the aggregate amount of one million five hundred seventy-one thousand seven hundred four (\$1,571,704) dollars.
- 7. From 2015-2018, Respondent violated Insurance Law § 3201 by charging the volunteer firefighter companies premium rates that were not supported by the Respondent's rating materials that were filed with the Department. Respondent's failure to use the premium rates on file with the Department resulted in certain New York volunteer firefighter companies being overcharged for premiums in the aggregate amount of one million two hundred thirteen thousand six hundred forty (\$1,213,640) dollars.

VIOLATIONS

- 8. By reason of the foregoing, Respondent violated 11 NYCRR 52.45(f) (Insurance Regulation 62), promulgated pursuant to Insurance Law § 3217, by failing to adequately maintain minimum loss ratio standards applicable to blanket accident and health insurance.
- 9. By reason of the foregoing, Respondent violated Insurance Law § 3201 by charging premium rates that were not supported by the Respondent's prior approved rating filings with the Department.

AGREEMENT

IT IS HEREBY AGREED AND ORDERED that Respondent and all of its subsidiaries, affiliates, successors, assigns, agents, representatives, and employees, shall comply with the following:

- 10. As a result of the Department's investigation:
 - a. Within ninety (90) days from the date of Respondent's execution of this Consent Order, Respondent shall make a new blanket accident and health policy and premium rates submission with the Department for review and approval that will replace all existing coverage issued to New York volunteer firefighter companies.
 - b. Respondent shall send a notice approved by the Department informing each of the impacted New York volunteer firefighter companies identified in both Appendix A and Appendix B of their retroactive rebates.
- 11. Respondent shall, by March 15, 2019, provide proof to the Department that each of the impacted New York volunteer firefighter companies identified in Appendix A has been provided retroactive rebates that are reflective of each New York volunteer firefighter

company's portion of Respondent's one million five hundred seventy-one thousand seven hundred four (\$1,571,704) dollars minimum loss ratio performance shortfall.

- 12. Respondent shall, by March 15, 2019, provide proof to the Department that each of the impacted New York volunteer firefighter companies identified in Appendix B has been provided retroactive rebates that are reflective of each New York volunteer firefighter company's portion of Respondent's one million two hundred thirteen thousand six hundred forty (\$1,213,640) dollars for the use of an unapproved premium rates.
- 13. Within ninety (90) days from the date of Respondent's execution of this Consent Order, Respondent shall provide an up-to-date detailed summary of the corrective actions taken, or proposed to be taken, in full compliance with this Consent Order.
- 14. Respondent shall also take all necessary steps to comply with the New York Insurance Law and Regulations with respect to its insurance policies in the future.
- 15. Respondent shall submit a report to the Department by May 1 of each year for the next five years, beginning on May 1, 2019, containing experience data for each blanket accident and health policy form issued to New York volunteer firefighter companies during the prior calendar year. Such experience data reporting shall be in a format acceptable to the Department and consistent with 11 NYCRR 52.44(a)(2). Upon review of the experience data report, the Department may require the Respondent to submit a corrective action plan in accordance with 11 NYCRR 52.44.

MONETARY PENALTY

16. Within seven (7) days of the execution of this Consent Order, Respondent shall pay a civil penalty of one million two hundred thousand (\$1,200,000) dollars. Respondent agrees that it will not claim, assert, or apply for a tax deduction or tax credit with regard to any U.S.

- federal, state or local tax, directly or indirectly, for any portion of the civil monetary penalty paid pursuant to this Consent Order.
- 17. The above referenced payment shall be payable to the New York State Department of Financial Services in accordance with the Department's instructions.

BREACH OF THE CONSENT ORDER

- 18. In the event that the Department believes Respondent to be materially in breach of this Consent Order ("Breach"), the Department will provide written notice of such Breach to Respondent and Respondent must, within ten (10) business days from the date of receipt of said notice, or on a later date if so determined in the sole discretion of the Department, appear before the Department and have an opportunity to rebut the Department's contention that a Breach has occurred and, to the extent pertinent, to demonstrate that any such Breach is not material or has been cured.
- 19. Respondent understands and agrees that Respondent's failure to appear before the Department to make the required demonstration within the specified period as set forth herein is presumptive evidence of Respondent's Breach. Upon a finding of Breach, the Department has all the remedies available to it under New York or other applicable laws and may use any and all evidence available to the Department for all ensuing examinations, hearings, notices, orders, and other remedies that may be available under New York or other applicable laws.

OTHER PROVISIONS

20. If Respondent defaults on any of its obligations under this Consent Order, the Department may terminate this Consent Order, at its sole discretion, upon ten (10) days' written notice to Respondent. In the event of such termination, Respondent expressly agrees and acknowledges that this Consent Order shall in no way bar or otherwise preclude the Department from commencing, conducting, or prosecuting any investigation, action, or proceeding, however denominated, related to the Consent Order, against Respondent or

from using in any way the statements, documents, or other materials produced or provided

by Respondent prior to or after the date of this Consent Order, including, without

limitation, such statements, documents, or other materials, if any, provided for purposes of

settlement negotiations.

21. The Department has agreed to the terms of this Consent Order based on, among other

things, representations made to the Department by Respondent and the Department's own

factual examination. To the extent that representations made by Respondent are later

found to be materially incomplete or inaccurate, this Consent Order or certain provisions

thereof are voidable by the Department in its sole discretion.

22. Upon the request of the Department, Respondent shall provide all documentation and

information necessary for the Department to verify compliance with this Consent Order.

23. All notices, reports, requests, certifications, and other communications to the Department

regarding this Consent Order shall be in writing and shall be directed as follows:

24. This Consent Order and any dispute thereunder shall be governed by the laws of the State

of New York without regard to any conflicts of laws principles.

- 25. Respondent waives its right to further notice and hearing in this matter as to any allegations of past violations up to and including the Effective Date and agrees that no provision of the Consent Order is subject to review in any court or tribunal outside the Department.
- 26. This Consent Order may not be amended except by an instrument in writing signed on behalf of all parties to this Consent Order.
- 27. This Consent Order constitutes the entire agreement between the Department and Respondent relating to the violations identified herein and supersedes any prior communication, understanding, or agreement, whether written or oral, concerning the subject matter of this Consent Order. No inducement, promise, understanding, condition, or warranty not set forth in this Consent Order has been relied upon by any party to this Consent Order.
- 28. In the event that one or more provisions contained in this Consent Order shall for any reason be held invalid, illegal, or unenforceable in any respect, such invalidity, illegality, or unenforceability shall not affect any other provision of this Consent Order.
- 29. Upon execution by the parties to this Consent Order, no further action will be taken by the Department against Respondent for the conduct set forth in this Consent Order, subject to the terms of this Consent Order.
- 30. This Consent Order may be executed in one or more counterparts, and shall become effective when such counterparts have been signed by each of the parties hereto and So Ordered by the Superintendent of Financial Services.
